**RESOLUTION TO EXPEL STUDENT "X6-07"
FOR A PERIOD OF TWELVE MONTHS**

WHEREAS, there is substantial evidence that student "X6-07" committed a serious and flagrant violation of school district policy and state law: possessing a weapon on school grounds and school locations and threatening to cause physical harm to another student; and,

WHEREAS, student "X6-07" and his father and natural guardian have signed and executed a *Waiver of Right to Hearing and Consent to Expulsion* for twelve months;

BE IT RESOLVED, by the school board of Independent School District No. 2142, that student "X6-07" be expelled for a period of twelve months commencing with February 28, 2007.

The motion for the adoption of the foregoing resolution was duly seconded by Bjerklie and upon vote being taken thereon, the following voted in favor thereof: Bjerklie, Krog, Salmela, B. Larson, A. Larson, and Fowler

**RESOLUTION TO EXPEL STUDENT "X7-07"
FOR REMAINDER OF 2006-2007 SCHOOL YEAR**

WHEREAS, there is substantial evidence that student "X7-07" committed a serious and flagrant violation of school district policy: Possession of a weapon on school grounds and school locations; and

WHEREAS, student "X7-07" and his parents and natural guardians have signed and executed a "*Waiver of Right to Hearing, Consent to Expulsion and Change of Placement, and Waiver of Due Process and Administrative Rights*" by which student "X7-07" and his parents and natural guardians have agreed and acquiesced to his expulsion for the remainder of the 2006-2007 school year;

BE IT RESOLVED, by the school board of Independent School District No. 2142, that student "X7-07" be expelled for the remainder of the 2006-2007 school year.
